We hereby inform you that we have collected data regarding you and that we are therefore Controllers with regard to processing them, pursuant to the law. The data in our possession include personal and tax data regarding you, obtained verbally, directly or through third parties, or already provided to us. We would like to specify that the processing of your data is motivated by the establishment or execution of the contractual relationships in place between us or being defined.

We would therefore like to inform you that these data will be processed using paper, IT or ICT means and notified to other companies, in full compliance with the fundamental principles laid down by Legislative Decree no. 196 of 30 June 2004 "Personal Data Protection Code".

In particular, the data will be processed for the following purposes:

- ◆ contractual needs and resulting legal obligations associated with civil and tax regulations deriving from them;
- ◆ effective management of commercial relationships, including marketing notices and promotions regarding our activities.

The provision of the data is obligatory to the extent that it is required by legal or contractual obligations and therefore refusal to provide it in whole or in part could make it impossible for MOLLIFICIO ADIGE S.r.l. to execute the contract and therefore guarantee its correct implementation.

Without prejudice to the notices given in fulfilment of legal and contractual obligations, all the data collected and processed may be notified and transferred throughout the territory of the nation, exclusively for the purposes specified, to:

- ◆ Public bodies (Insurance companies, Police, Local authorities, Health authorities and the State Financial Administration);
- ◆ Professionals or service firms for company administration and management who operate on behalf of our company;
- ◆ IT companies, exclusively with regard to the hardware and software maintenance needs of our computers;
- ◆ Banks and financing and lending firms;
- ◆ Companies for the recovery of credits and for insuring credits;
- ◆ Any private or public body, exclusively for complying with the legal or contractual obligation.

With regard to the data processed, you may exercise the rights envisaged by art. 7 of Leg. Decree 196/2003, within the limits and under the terms envisaged by arts. 8, 9 and 10 of the aforesaid legislative decree.

The above-mentioned data will also be kept after the conclusion of the contractual relationship, for the fulfilment of all the obligations associated with or arising out of the conclusion of the relationship itself.
