

Cookie Policy

Complete policy on cookies and their use

Cookies are portions of programming code inserted inside the browser to help the site owner to provide services according to the purposes declared. Cookies that require the consent of the user may be present.

Technical cookies and cookies used to collect statistics

Activities necessary for site operation

This site uses cookies to register the user session and for other activities necessary for site operation, such as for example the recording of data on traffic.

Storage of preferences, optimization and statistics

This site uses cookies to save navigation preferences and to improve the navigation experience of users. For example, settings for language or currency and the acquisition of statistics are managed by cookies.

Other cookies or third-party tools that may use cookies

Below are some of the services that collect aggregate statistical data that do not require explicit user consent or that can be operated by the site owner without using third-party services.

Business affiliation

Glossary of Definitions and Legal References

Personal Data (or Data)

Personal data means any information regarding a natural person that is or may be identified, even indirectly, by reference to any other information, including a personal identification number.

Site Data

These personal data include information collected automatically by the site (or by third-party applications linked to it), such as: IP addresses or domain names of the computers used by the user accessing the site, addresses in URI (Uniform Resource Identifier) format, the time of the request, the method used to submit the request to the server, the dimensions of the reply file, the numerical code of the status of the server reply (error, success, etc), the country of origin, the characteristics of the browser and operating system used by the visitor, miscellaneous information on visit times (for example, the time spent on each page), and details of the navigation route followed inside the site (sequence of pages visited, user operative system and IT environment).

User

The person using the site, which is the Interested Party or any other person authorized by the Interested Party, whose personal data are the subject of data processing.

Interested Party

The natural or legal person to which the personal data refer.

Supervisor of Data Processing (or Supervisor)

The natural or legal person, public administration or any other agency, association or entity assigned by the Controller to the processing of personal data, as envisaged by this privacy policy.

Controller of Data Processing (or Controller)

The natural or legal person, public administration or any other agency, association or entity responsible, either individually or jointly with any other controller, for decisions on the purposes and methods of data processing and the instruments used, including data security procedures, with regard to the operation and use of the site. The Controller of Data Processing, unless otherwise specified, is the site owner.

Site (Application)

The software instrument (and the respective hardware instruments linked to it) by means of which personal data on users are collected.

Cookie

Small portion of data stored inside the terminal device of the user.
